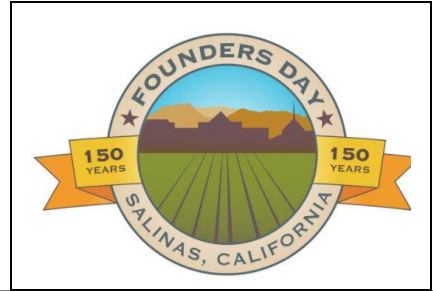

# TERMS & CONDITIONS

## **PLEASE INCLUDE THE FOLLOWING WHEN SUBMITTING YOUR APPLICATION:**

### **ALL CRAFTS & COMMERCIAL VENDORS:**

A photocopy of your California Seller's Permit. For more information, Contact the State Board of Equalization at (831) 443-3003 for more information.

SET-UP Time will be the day of the event from 6:00AM until 8:00AM. Absolutely no vehicles will be allowed on the premises after 8:00AM. The standard booth space is 10' x 10'.

Vendors will be notified of admittance based on availability and diversity of products. A completed application does not guarantee acceptance. Admission to the event will be on a first come, first served basis based on a completed application AND payment. Once spaces are filled up, vendors will be placed on a waiting list and notified of a space should one be available.

By signing this application, I hereby agree that I have read and understand the "Rules and Regulations" of Salinas Founders Day. I fully understand that the booth must meet all Salinas Founders Day standards and conditions and can and will be shut down, without a refund, for noncompliance of these standards. Event policy dictates no refunds for vendor cancellations and assesses a \$35 fee for returned checks. All craft participants of this event agree to indemnify, hold harmless, and release Salinas Founders Day and its staff and volunteers of any loss, damage, or injury that might occur in connection with this event. The undersigned agrees to indemnify and hold harmless the Salinas Founders Day, the City of Salinas, and the property owners from all damages, liabilities, costs, and expenditures including attorney's fees. Payment of your application fee does not guarantee a space or a specific location in the event.

### **ART/ CRAFT VENDORS:**

Only handmade crafts, unique crafts, specialty items and collectibles of high quality may be sold at the Salinas Founders Day Event. The Indian Arts & Crafts of 1990 is a truth-in-advertising law. It is illegal to offer or display for sale, or sell any art or craft product in a manner that falsely suggests it is Indian produced, an Indian product of a particular Indian tribe. CIVIL & CRIMINAL PENALTIES:

For a first time violation of the Act, an individual can face civil penalties or criminal penalties up to a \$25,000 fine or a 5-year prison term, or both. If a business violates the Act, it can be prosecuted and fined up to \$1,000,000. ### **FOOD VENDORS:**

The Salinas Founders Day will take care of the fees and permitting associated with the Salinas Fire Department. Vendors will be required to follow all applicable laws concerning cooking with an open flame including possession of an up to date "Class C" rated fire extinguisher. Food Vendors will be required to obtain the proper permitting from the Health Department of Monterey County. This may require a Temporary Food Facility Permit. "Food Vendors" may be required to tent and / or screen their food production and sales area as required by the Monterey County Health Department. All food vendors will be required to follow all rules and guidelines set forth by the Health Department and may be subject to their inspection. The Salinas Founders Day Committee is not responsible should the

Monterey County Health Department decide to shut you down. For more information, contact the Monterey County Health Department at (831) 722-4500.

Food Booths will be selected for variety and cleanliness. At the time of the application, each Vendor will submit copies of all documents applicable to the sales of their product including California Seller's Permit and Health Permit, if applicable. Each Food Vendor must provide a 33-gallon container for customer garbage. All vendors are asked to bring their own trash can and dispose of their own trash.

Admission of a Vendor shall be at the discretion of Event Organizers. All Vendors must comply with the rules and regulations of the State Board of Equalization and County Health Departments, and all other State and County governmental agencies that regulate the sales of the Vendor's products. The vendor spaces must be completely clean as soon as possible, not to exceed one hour after the conclusion of the event.

There will be ABSOLUTELY NO EARLY DEPARTURES. All Vendors must stay for the duration of the event. The event will conclude at 3:00PM and the street will be opened to traffic immediately there after. Vendors are responsible for removing their entire display and vehicles from the 200 block of Main Street immediately after the conclusion of the event. All sales transactions must stop at the designated closing time.
